TERMS OF PAYMENT: All accounts are strictly net and payable in 30 days for Freight and other charges. In addition, where a transaction would cause the amount of THE APPROVED CREDIT LIMIT to be exceeded, the EXCESS above the APPROVED CREDIT LIMIT will be paid IMMEDIATELY. Transport MTL INC/Container Express/TotalShip will establish the credit line for the account and may periodically raise, lower or revoke credit line and put the account on a C.O.D. basis until the account has been cleared.

INTEREST CLAUSE: It is understood and agreed that Transport MTL/Container Express/ TotalShip will charge interest on all accounts outstanding for more than thirty (30) days from the date of the invoice, at a rate of 2% per month (24% per annum). This may change without prior written notice.

MISCELLANEOUS: The client shall notify Transport MTL Inc/Container Express/TotalShip immediately of any change of name or address.

This agreement shall not be affected by change in the name of the client, or by the acquisition of the client's business by a corporation or by any change whatsoever in the objects, capital structure or constitution of the client, or by the client's business being amalgamated with a corporation.

PAST DUE: In the event that it becomes necessary for Transport MTL/Container Express/TotalShip to refer to a collection agency and/or attorney, all costs including, but not limited to: fees paid to collection agencies and reasonable attorney and/or legal fees are to be paid by the debtor.

COMMENCEMENT OF ACTION: The undersigned Purchaser agrees that if any legal action is commenced by or on behalf of Seller with respect to the Purchaser, that venue is proper in all Canadian Courts.

SECURITY FOR CREDIT: As security for credit terms herein, the undersigned client grants Transport MTL/Container Express/TotalShip security interest in goods and equipment and in the personal property, which is or will be in the possession of the undersigned company, as well as security interests in the client's accounts. Title and ownership of goods, which are handled by Transport MTL/Container Express/TotalShip shall remain with and are granted to Transport MTL/Container Express/TotalShip until the account is paid in full.
